### **Responsibilities**

The University of Central Florida is one of the nation's largest, with over 68,000 students, more than 9,000 of whom are graduate students. Previously handled by two individuals, this position was developed to facilitate meeting the research and graduate studies goals in the university Strategic Plan by creating a synergy between faculty conducting research and the graduate students who form the backbone of many laboratories. Both roles require overseeing large budgets and working collaboratively with the leadership and faculty across all colleges, including a College of Medicine and an Academic Health Sciences Center, multiple campuses, and within centers, institutes, and research clusters. The position also involves working with industry, the military, local business and governmental communities, and virtually every administrative unit in the university. The Vice President for Research has fiduciary and compliance responsibility and oversight for all research conducted in the name of the university; this includes developing appropriate policies and procedures, overseeing the creation of innovative technologies and ideas, bringing these to the marketplace, and ensuring that faculty and university interests are well-represented. The Vice President for Research also chairs the UCF Research Foundation Board. The Dean of the College of Graduate Studies provides academic leadership for the development of new programs and the recruitment and retention of students into existing programs at the master's, doctoral, and post-doctoral levels and provides promotion and tenure review for faculty with tenure homes in the College.

## **College of Graduate Studies**

Graduate student enrollment: Fall 2015, 8,029; Fall 2016, 8,066; Fall 2017, 8,725; Fall 2018, 9,316 (6.82% increase over the previous year)

- Implemented new Graduate School Application system, SLATE, to improve the efficiency of application services, modernize business practices, and improve communication systems with all potential and actively applying students
- Hired an Associate Director of Recruitment to allow for the development of focused initiatives and efforts both internal and external to UCF
- Developed the Diverse Academic Opportunities Program to recruit students of diverse backgrounds to our STEM Ph.D. programs
- Established new Graduate Enrollment data reports that better link college-level enrollment projections to meeting the institutional goal of 10,000 grad students
- Facilitated the state-level approval of four new Ph.D. programs (in Big Data, Anthropological Sciences, Aerospace Engineering, and Strategic Communication)
- Increased the number of Office of Research-funded, higher level fellowships from 92 (AY 2016-2017) to 104 (AY 2017-2018) to 115 for AY 2018-2019
- Raised salaries of doctoral-level Graduate Teaching and Graduate Research Assistants to be competitive with other Florida and University Innovation Alliance peers
- Implemented a graduate research grant program for doctoral students, to assist with small research expenses to complete dissertations
- Began implementation of a digital annual reporting system to track progress of doctoral students and post-doctoral fellows, consistent with NIH requirements for an Individual Development Plan
- Instituted a doctoral student “bridge” funding program to cover stipends of students whose faculty mentors have a brief (less than one year) interruption in grant funding for students
- Developed and implemented a program to cooperatively fund post-doctoral fellows to reach the university goal of 200. Total number of fellows before the program (November, 2016) was 62; there are currently 162, with over 45 more in the pipeline (i.e., search underway, going through hiring process)
- Instituted a reevaluation and reworking of how graduate student academic and other misconduct is handled

- Restructured the Office of Research to make it more efficient, effective and user friendly by:
  - hiring a new Associate Vice President for grants and contracts
  - promoting an Assistant Vice President to Associate Vice President to work directly with faculty
  - implementing a new electronic research administration system
  - relocating post-award staff formerly housed in and reporting to Finance and Accounting to the Office of Research, and training them to be grant administrators

- reorganizing grants and contracts staff and duties
- revamping the Institutional Review Board, including initiating a second IRB to serve the biomedical sciences
- implementing digital security protocols to meet government required NIST 800-53-level standards
- and developing master agreements, contracts, and NDAs to speed up review and completion of contracts and documents
- Assumed responsibility for the interdisciplinary faculty cluster initiative. The University has invested over \$45,000,000 in these faculty clusters. The Office of Research now oversees the clusters including hiring, startup, grant preparation, and training/consultation to ensure that this new research initiative is successful
- Supported the implementation of programs to encourage grant submissions and to facilitate making them successful when grants are submitted, including:
  - Training through the Researcher Experience Development initiative (REDi): Writing Large Multi-Disciplinary Proposals
  - Offering a course release or one months' summer salary to 6 PIs interested and able to prepare large proposals (over FY 17 and 18)
  - Implementing a mentoring program, where 30 senior/junior pairs work together on specific funding opportunities; mentors are provided a small incentive when proposals are submitted and when they are successful
  - Providing targeted support for developing large research proposals (ReACT).
  - Providing other support for research leading to external funding including: seed funding through a variety of mechanisms (e.g., work conducted jointly with Mayo Clinic and Florida Hospital, the Vice-President for Research Advancement of Early Career Researchers awards, and travel awards); distributing funding announcements to faculty (322 funding announcements sent in FY 2016-2017); arranging for NSF program manager visits by 17 new faculty in 2016 and 13 in 2017; providing approximately 60 workshops on conducting research to over 500 attendees; and reviewing proposals before submission.
- Increased faculty recognition for research and scholarship
  - Formally recognize Early Career Grant Recipients
  - Developed a new award, the Luminary Award, given to faculty in a special ceremony to recognize those who have received national and international recognition for their scholarship and research
  - In cooperation with the library, implemented a "book launching" to celebrate UCF faculty who have written books in the past five years
- Increased involvement in the Undergraduate Research Initiative with the goal of combining both graduate and undergraduate research and scholarship into a single, large Research and Scholarship Week in the future
- Implemented a new communications and marketing strategy, including hiring a new Executive Director of Communication and Marketing, to ensure that the work being done by the faculty receive adequate recognition in the media
- Assumed responsibility for the Office of Environmental Health and Safety. This enables EH&S to better achieve its goals by allowing for more cooperation between Health and Safety Officers and faculty.
